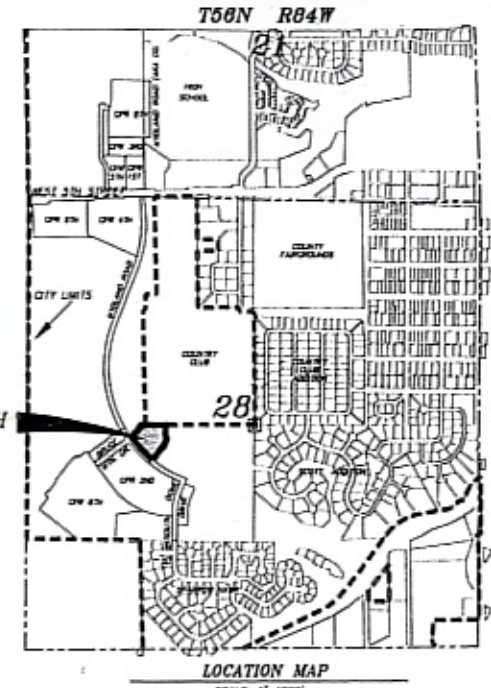

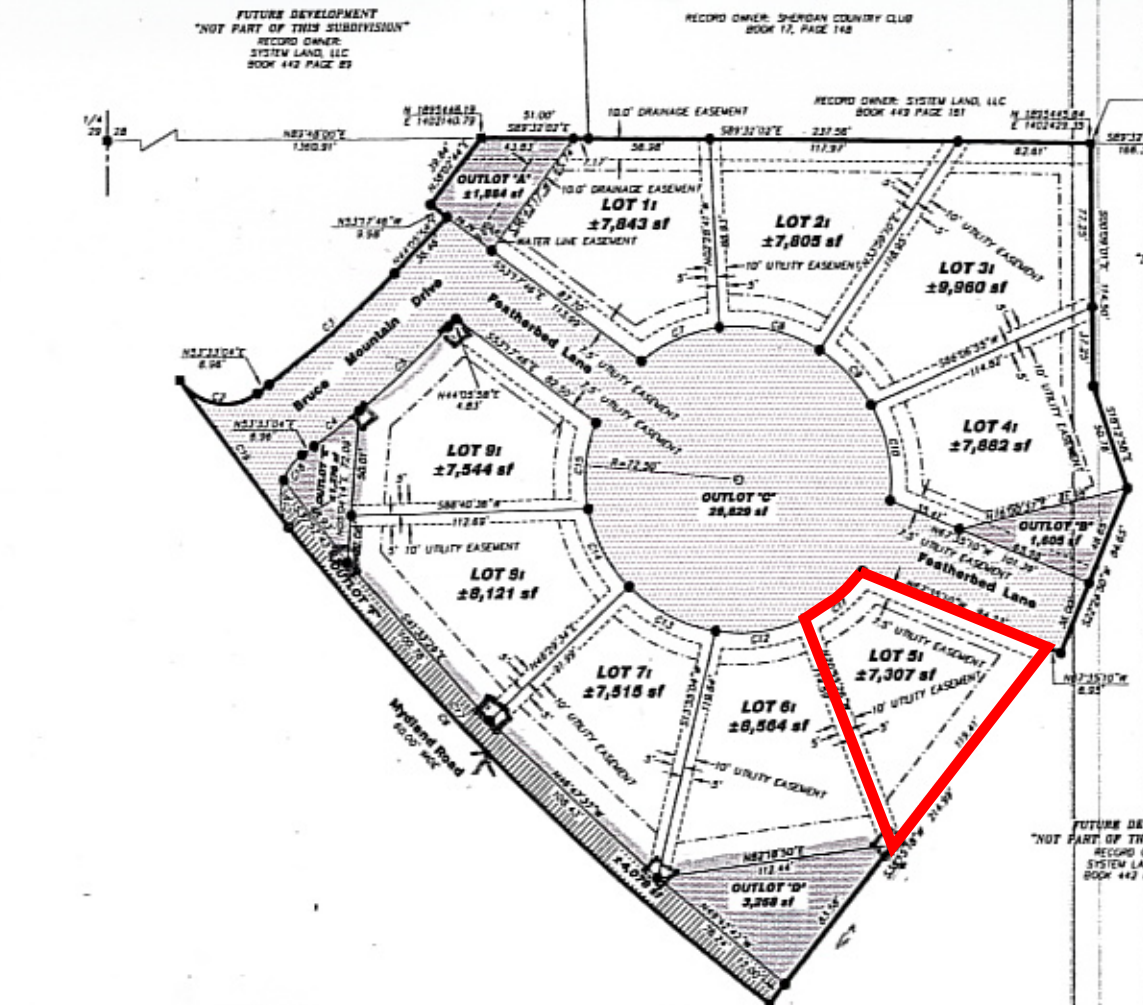

KNOWN ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED SYSTEM LAND, LLC, BEING THE OWNER, PROPRIETOR OR PARTY OF INTEREST IN THE LAND SHOWN ON THIS PLAT, DOES HEREBY CERTIFY THAT THE FOREGOING PLAT DESIGNATED AS CLOUD PEAK RANCH SEVENTH FILING, IS SHOWN IN THE S1/2NW1/4 AND N1/2SW1/4 OF SECTION 28, TOWNSHIP 58 NORTH, RANGE 84 WEST, 6TH PRINCIPAL MERIDIAN, CITY OF SHERIDAN, SHERIDAN COUNTY, WYOMING, SAID TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SAID S1/2NW1/4, SAID SOUTHWEST CORNER ALSO BEING THE COMMON CORNER TO THE SOUTHWEST CORNER OF THE COUNTRY CLUB ADDITION AND THE NORTHWEST CORNER OF SCOTT ADDITION TO THE CITY OF SHERIDAN (INCORPORATED WITH A 3" BRASS CAP PER PLS 2517 & PLS 2518); THENCE N87°12'21"W 108.80 FEET TO THE POINT OF BEGINNING OF SAID TRACT; SAID POINT LING ON THE NORTH LINE OF A TRACT OF LAND DESCRIBED IN BOOK 448, PAGE 181; THENCE S00°09'01"E 114.50 FEET TO A POINT; THENCE S87°12'21"W 30.78 FEET TO A POINT; THENCE S22°24'30"W 84.85 FEET TO A POINT; THENCE N87°35'10"W 8.85 FEET TO A POINT; THENCE S32°18'18"W 314.99 FEET TO A POINT; SAID POINT LING ON THE NORTHERLY RIGHT OF WAY LINE OF WYLAND ROAD; THENCE THROUGH A NON-TANGENT CURVE TO THE RIGHT, HAVING A RADIUS OF 1370.00 FEET, A CENTRAL ANGLE OF 17°00'31", AN ARC LENGTH OF 408.71 FEET, A CHORD BEARING OF N42°12'18"W, AND A CHORD LENGTH OF 402.22 FEET TO A POINT; THENCE THROUGH A NON-TANGENT CURVE TO THE LEFT, HAVING A RADIUS OF 28.00 FEET, A CENTRAL ANGLE OF 91°49'37", AN ARC LENGTH OF 41.83 FEET, A CHORD BEARING OF S02°18'21"E, AND A CHORD LENGTH OF 37.31 FEET TO A POINT; THENCE N52°12'04"E 6.38 FEET TO A POINT; THENCE THROUGH A CURVE TO THE LEFT HAVING A RADIUS OF 483.00 FEET, A CENTRAL ANGLE OF 09°37'08", AN ARC LENGTH OF 80.01 FEET, A CHORD BEARING OF N48°48'31"E, AND A CHORD LENGTH OF 73.82 FEET TO A POINT; THENCE N44°25'58"E 38.48 FEET TO A POINT; THENCE N27°18'44"E 5.28 FEET TO A POINT; THENCE N48°02'44"E 38.84 FEET TO A POINT; THENCE S89°32'02"E 31.00 FEET TO A POINT; SAID POINT BEING AN ANGLE POINT OF A TRACT OF LAND DESCRIBED IN BOOK 448 OF DEEDS, PAGE 181; THENCE S89°32'02"E 232.58 FEET ALONG THE NORTHERLY LINE OF SAID TRACT DESCRIBED IN BOOK 448 OF DEEDS, PAGE 181 TO THE POINT OF BEGINNING OF SAID TRACT.

SAID TRACT CONTAINS 2.61 ACRES OF LAND, MORE OR LESS.
